

**SERVICE ATTACHMENT FOR SAAS 1
UNDER
MASTER CLOUD SERVICES AGREEMENT #MCSA0102**

This Service Attachment for SaaS 1 under Master Cloud Services Agreement #MCSA0102 (the "Service Attachment") is between CrowdStrike, Inc. ("Contractor"), having an office at 150 Mathilda Place, 3rd Floor, Sunnyvale, California 94086, and the State of Ohio ("State"), through the Department of Administrative Services ("DAS"), having its principal place of business at 30 East Broad Street, 40th Floor, Columbus, Ohio 43215. The State and the Contractor are sometimes referred to jointly as the "Parties" or individually as a "Party." This Service Attachment is effective as of the date signed by the State and amends that certain Master Cloud Services Agreement #MCSA0102 between the Parties with the same effective date (the "Agreement").

1. Definitions.

The defined terms in the Agreement will have the same meanings in this Service Attachment as they do in the Agreement. There may be additional definitions contained herein.

2. Services.

2.1 Overview. Contractor will provide the following Services purchased by a Subscriber pursuant to an Order:

a. Falcon Prevent – Next-Generation Antivirus:

- Machine learning-driven malware protection
- Unique Indicator of Attack ("IOA") behavioral blocking
- Signature-less malware protection
- Attack timeline visibility and data

b. Falcon Insight – Endpoint Detection & Response:

- Indicator of Attack (IOA) behavioral detection
- Captures and correlates kernel-level system events
- Visibility of security-related endpoint activity
- Search to discover and investigate current and historic endpoint activity
- Events can be contextualized by threat intelligence, providing attribution and additional information about the threat
- Run commands on a Windows or macOS host directly from the Falcon console to perform response and remediation tasks

c. Falcon Discover – IT Hygiene:

- Inventory applications in the environment
- Privileged user account monitoring
- System inventory of managed and unmanaged devices in the environment

d. Falcon Spotlight – Vulnerability Assessment:

- Identifies Windows operating system: vulnerabilities, missing patches, and current patch level
- Dashboards and reports allow users to see aggregate statistics about Windows operating system vulnerabilities and missing patches
- Users can query for a specific CVE (vulnerability ID), endpoint aka host name, or Microsoft KB ID to see related hosts

e. Falcon Device Control – USB Monitoring and Policy Enforcement:

- Provides policy creation and enforcement capabilities for USB device usage on Windows endpoints
- Block USB device usage by a predefined set of classes, or create rules and exceptions based on USB device vendor, product, or serial numbers
- Reports on USB-related usage activity, such as USB devices used on hosts, policies applied, and other USB-related usage information

f. Falcon Firewall Management – Firewall Management and Policy Enforcement: Provides policy creation and enforcement capabilities for host firewalls.

g. Threat Graph – Using endpoint telemetry, threat intelligence and AI-powered analytics, CrowdStrike Threat Graph is a cloud-native solution that collects, queries and analyzes large volumes of security events.

h. Falcon OverWatch provides threat detection services by proactively hunting Falcon Platform data for new and unique methods that adversaries use to achieve their intent on your computers.

Data security information:

- a. The Service does not host or process Subscriber Data outside the United States.
- b. The Service does not comply with the requirements to process Protected Health Information.
- c. The Service does not comply with the requirements to process Federal Tax Information.
- d. The Service does not comply with the requirements to process Criminal Justice Information Systems data.

2.2 Standard Service Features. See the Services described in Section 2.1 above. The Services are hosted within the boundary of the applicable FedRAMP (at least moderate) or DISA baseline accreditation and authority to operate by the U.S. Federal Government.

2.3 Optional Service Features. None.

2.4 Provision of Services. The Contractor will make the Services available to the Subscribers for purchase pursuant to the Agreement, including this Service Attachment. The State agrees that purchases hereunder are neither contingent on the delivery of any future functionality or features nor dependent on any oral or written public comments made by the Contractor regarding future functionality or features.

2.5 Support. The levels and descriptions of technical support for the Services available under this Service Attachment are described in Exhibit II to the Agreement.

3. Fees and Payment

3.1 Pricing. The specific pricing for this Service Attachment is set forth in Addendum 1 attached hereto and incorporated herein.

3.2 Fee Structure and Payment. The Subscribers will pay all fees specified in all Orders hereunder, subject to the terms of the Agreement. Except as otherwise specified in the Agreement, fees are based on Services purchased and not actual usage, and the number of Object subscriptions (e.g., the number of users) purchased cannot be decreased during the relevant Order Term. They may, however, be increased during an Order Term. The Contractor's Services are sold on a subscription basis, which means that the Subscriber shall be authorized by the Contractor to access and use the Services for a defined period of time as set forth in the applicable Order (e.g., 12 months). This subscription period or Order Term (as defined in the Agreement) shall begin on the subscription start date and end upon the expiration of such subscription period (e.g., upon the 12-month anniversary thereof), unless terminated earlier in accordance with the Agreement; therefore, fees for Object subscriptions added in the middle of an Order Term will be prorated for the remaining portion of such Order Term and shall co-term with the original subscription. No Order may specify a Service or provision not identified and/or priced in this Service Attachment, nor may it cover any billable services not listed in this Service Attachment as a Service.

If a Subscriber has not paid the fees specified in an Order by 30 days from the payment due date, the Contractor may suspend a delinquent Subscriber's access to the unpaid Services until all delinquent amounts are paid upon written notice to the Subscriber, notwithstanding any prohibition against self-help provided for elsewhere in the Agreement. However, Contractor may not suspend Services if the Subscriber is disputing the applicable charges reasonably and in good faith and is cooperating diligently to resolve the dispute.

3.3 Invoicing. Fees will be invoiced in-full upfront (unless otherwise agreed to by the Subscriber and the Contractor) and otherwise in accordance with the Agreement. Fees are due in accordance with the terms of the Agreement and this Service Attachment, which no Order may alter. The Subscriber is responsible for providing complete and accurate billing and contact information to the Contractor and notifying the Contractor of any changes to such information.

4. Proprietary Rights

4.1 Reservation of Rights in Services. Subject to the limited rights expressly granted hereunder, the Contractor reserves all rights, title, and interest in and to the Services, including all related intellectual property rights. No rights are granted to the State or Subscribers hereunder other than as expressly set forth herein or elsewhere in the Agreement.

4.2 Restrictions. Subscribers will not intentionally permit any third party to access the Services, except as permitted herein or in an Order, create derivative works based on the Services except as permitted in the Agreement, reverse engineer the Services, or access the Services to build a competitive product or service or to copy any features, functions, or graphics of the Services.

4.3 State Applications and Code. If a Subscriber, a third party acting on a Subscriber's behalf, or a user creates applications data or code using the Services, such will be part of the Subscriber Data. The Subscriber authorizes the Contractor to host, copy, transmit, display, and adapt such Subscriber Data solely as necessary for the Contractor to provide the Services in accordance with this Agreement. Further, the Subscriber will be entitled to port, use, modify, disclose, license, sell, and host such anywhere.

4.4 Subscriber Data. Subject to the limited rights granted by a Subscriber hereunder, the Contractor acquires no right, title, or interest from a Subscriber or its licensors under this Agreement in or to the Subscriber Data, including any intellectual property rights therein.

5. Service Levels

5.1 General. The Contractor must use commercially reasonable efforts to make the Services Available (defined in the Agreement) to Subscribers during the Order Term, except as set forth in Exhibit II to the Agreement or any Unavailability covered by the Agreement's Excusable Delay clause.

5.2 SLAs for the Services. The Service Level Agreements ("SLAs"), including credits for performance below the SLAs, are provided in Exhibit II to the Agreement.

6. Term and Termination

6.1 Term of Service Attachment. This Service Attachment is effective on the date of State signature below and remains in effect for the term of the Agreement unless earlier terminated by written agreement of the Parties.

6.2 Term of Subscriptions. Subscriptions purchased under this Service Attachment commence on the start date specified in the applicable Order and continue for the subscription term specified therein, subject to relevant provisions in the Agreement, such as the Agreement's termination and non-appropriation provisions. Should a Subscriber elect to renew a subscription, provided this Agreement and Service Attachment remain in effect, the renewal will be at the Subscriber's option and will be under the same terms and conditions and subject to the specific pricing set forth in Addendum 1 attached hereto; provided, however, that the Contractor and such Subscriber shall be free to negotiate other commercial terms (e.g. length of subscription term, discounts, etc.) that do not change the provisions of the Agreement. If a change in law, rules, or regulations requires a modification of the renewal price or any terms and conditions in this Service Attachment, the Parties will in good faith negotiate the modifications necessitated by such a change, and any modifications will only be effective upon a written agreement signed by the Parties.

7. Miscellaneous

7.1 Return of Subscriber Data. At no additional cost to the Subscriber, the Contractor will make available to the Subscriber for download its Subscriber Data, in native format (a) at any time during an Order Term and (b) during the remainder of the applicable data retention period purchased by the Subscriber after the effective date of termination or expiration of a Subscriber's Order for that Service, provided that prior to such expiration or termination, the Subscriber has

issued a technical support ticket requesting continued access be made available. After the expiration of the applicable data retention period, the Contractor will have no obligation to maintain the Subscriber Data covered by an expired Service Order and must thereafter, unless legally prohibited, delete the applicable Subscriber Data in its systems or otherwise in its possession or under its control.

7.2 Access and Use Rights. Subject to the terms and conditions of this Service Attachment and the Agreement, the Contractor grants to the Subscriber a non-exclusive, non-transferable, non-sublicensable license to access and use the Services in accordance with any applicable Documentation solely for the Subscriber's Internal Use during the applicable Order Term. The Subscriber's access and use is limited to the quantity in the applicable Order. If the Subscriber purchases a subscription to a Service with a downloadable object-code component ("Software Component"), the Subscriber may, during the Order Term, install and run multiple copies of the Software Components solely for the Subscriber's Internal Use up to the maximum quantity in the applicable Order.

7.3 Falcon Platform. The 'Falcon EPP Platform' uses a crowd-sourced environment, for the benefit of all customers, to help customers protect themselves against suspicious and potentially destructive activities. The Contractor's Services are designed to detect, prevent, respond to, and identify intrusions by collecting and analyzing data, including machine event data, executed scripts, code, system files, log files, dll files, login data, binary files, tasks, resource information, commands, protocol identifiers, URLs, network data, and/or other executable code and metadata. The Subscriber, rather than the Contractor, determines which types of data, whether personal data or not, exist on its systems. Accordingly, the Subscriber's endpoint environment is unique in configurations and naming conventions and the machine event data could potentially include Subscriber's Data, including personal data. The Contractor uses the data to: (i) analyze, characterize, attribute, warn of, and/or respond to threats against the Subscriber and other customers, (ii) analyze trends and performance, (iii) improve the functionality of, and develop, the Contractor's products and services, and enhance cybersecurity; and (iv) permit customers to leverage other applications that use the data, but for all of the foregoing, in a way that does not identify the Subscriber or identify or disclose personal data to other customers.

IN WITNESS WHEREOF, the Parties have executed this Service Attachment, which is effective on the date the State's duly authorized representative signs it on behalf of the State.
